Enclosed please find the TDC Application form as well as my bio and personal information indicating my interest in an open position on the Pinellas County Tourism Development Council.

I hope my involvement in the industry, franchise, education, and civic activities confirm my history and interest in giving back to the communities and groups that have been a part of my industry success. No matter where I have lived during my career, it has always been my goal to become involved in the community and match my background, talents and business strengths to the needs of that community.

It's not sufficient to merely provide a product and/or service for pecuniary gain. I learned long ago from my father (who was active in the Pinellas County business and banking community) that one of the modules of any successful business venture is that of "Good Corporate Citizen." Though few "Business 101" classes may include that perspective, I suggest it remains valid.

I began my hotel career as a bellhop the summer I graduated from Clearwater Central Catholic High School at what was the Statler Hilton Resort on Clearwater Beach. I have operated resort and commercial hotels around the country during my career, with 30 years of multi-unit hotel supervision as a corporate CEO with as many as 33 hotels at one time.

While the five hotels BayStar Hotel Group currently owns and/or operates are primarily business hotels by definition, the three Pinellas County hotels – the Hampton Inn and Suites, Largo; Holiday Inn Express and Suites, Largo; and the Hotel Indigo, Downtown St. Petersburg – serve both corporate and transient tourism market segments. I would hope to represent the interests of the St. Petersburg market balanced with both Mid-Pinellas area and county-wide perspectives. I believe I could offer the TDC representation and entry to the many business hotels that may understand the importance of tourism on their

revenue line, but may not know how to become more engaged in VSPC activities.

All Florida is a Tourist Destination! For Pinellas County to continue to prosper in "high tourism impact," many more need to recognize the importance of this source of business – that it's not just a charter flight in and out of PIE, or an occupied room at a beach hotel – but that every traveler who sets foot within the county lines becomes an opportunity for each of us to further the objectives of VSPC. Attracting new visitors may have a direct cost; encouraging return visits drives profits.

My comments are merely intended to show my passion for hospitality, my lifelong career. While I keep up to date on the VSPC statistics and marketing plans, I recognize my lack of knowledge to specifics of the current TDC agenda. That learning curve would be a positive growth experience for me, understanding that I certainly don't have all the answers to the many challenges, nor the ego to suggest that.

From my previous work with other industry, civic and franchise organization boards, I fully understand that my personal business takes a back seat to the organization's interest. In this case I would call upon my industry and area knowledge, my study of the agenda and background data to provide my best counsel regarding the county tourism program. That said, VSPC has a formidable track record, holds a high level of respect within their "field of play," and is blessed with a strong and professional staff that performs the "heavy-lifting" of tourist development extremely well.

If selected, my goal would be to offer salient, studied opinions, ask appropriate questions and complement the process and progress. I would acknowledge the duty of required oversight by looking for ways to provide support for the annual plan and agenda and to be a cheerleader to those hoteliers who may be standing on the sidelines wondering how to become more involved.

While growing up in the Largo area, George began his Hospitality Industry career as a bellman at the Statler Hilton Hotel, Clearwater Beach, FL the summer he graduated from Clearwater Central Catholic High School. He continued that Hospitality focus each summer during college, thereafter building a successful career, a lifelong passion and devotion to the Hospitality and Tourism Industry.

In 2000 George returned to Florida co-founding BayStar Hotel Group, LLC Tampa, FL, a hotel development and management company that currently owns and/or operates 5 hotels, previously having developed, acquired or sold 5 other hotels in the state of Florida. Three of those hotels are in Pinellas County, Hampton Inn and Suites – Largo; Holiday Inn Express and Suites – Largo; both developed 2 blocks from his Father's Largo Theatre site where he worked as a youth; the Hotel Indigo – Downtown St. Petersburg was acquired, renovated and re-branded in 2009. George resides in Belleair Bluffs, Pinellas County, FL living in the home where he was raised.

Mr. Glover serves as BayStar's Chief Executive Officer - responsible for the overall strategic direction of the company, its growth through new construction projects, franchise affiliations, asset acquisitions, development of its management contract portfolio, as well as day to day hotel operations.

From 1983 until 2000, Mr. Glover was President and Chief Executive Officer of Wilson Hotel Management Co., Inc. (WHMC), a Memphis, TN. based division of the Kemmons Wilson Companies. WHMC had owned and operated eleven Holiday Inn Hotels, ten Wilson Inn Hotels, six Wilson World Hotels, three Sheraton Hotels, a Hilton Resort Hotel, and two Hampton Inn and Suites. He was responsible for long range strategic planning, overall operations, business management, and continuous evaluation of WHMC's operations. In addition, he served as EVP, Managing Director of the Orange Lake Country Club, a 1400 plus unit Orlando, FL timeshare resort and assisted with the development and market positioning of Holiday Inn Founder - Kemmons Wilson's new hospitality concepts, Wilson World Hotels and Wilson Inns.

Prior to 1983, he was a District Director for Holiday Inns, Inc. with the responsibility for the operation of thirty plus company owned and franchised properties covering 5 states. Mr. Glover began his career with AIRCOA and has been general manager of six different hotels, both commercial and resort properties throughout the United States; and has held various operations management positions.

George has served as Chairman, InterContinental Hotels Group (IHG) Owners Association – as well as Interim President and CEO, InterContinental Hotels Group (IHG) Owners Association, and as Chair of several IHG Owners Association Brand (Holiday Inn Express and Hotel Indigo), Enterprise Value, and Global Strategy committees for the international franchise community of IHG Owners. In 2004 he was honored with the inaugural Kemmons Wilson Award from IHG Owners Association for extraordinary service to the global owners association. Currently a Board Member, Florida Restaurant and Lodging Association, and former Chair - FRLA Finance and Administration Committee; and Florida Restaurant and Lodging Association Government Relations Committee. Florida Department of Business and Professional Regulation, Division of Hotels and Restaurants Advisory Board-Vice Chair; former Co-Chair, AH&LA Council of Management Companies.
