Adoption of a Resolution for the Annual Observance of Veterans' Service by Waiving Fees at County Parks and Park Facilities on Veterans Day.

**Recommended Action:**

I RECOMMEND THE BOARD OF COUNTY COMMISSIONERS (BOARD) ADOPT A RESOLUTION FOR THE ANNUAL OBSERVANCE OF VETERANS' SERVICE AND WAIVE ALL PARKING FEES, TO INCLUDE BEACH AND BOAT RAMP PARKING, AT ALL COUNTY PARKS AND PCR FACILITIES ON THE RECOGNIZED FEDERAL VETERANS DAY HOLIDAY EACH YEAR.

**Summary Explanation/Background:**

At the June 24, 2014 Board meeting, the Board voted to waive parking fees at Fort De Soto Park, Sand Key Park and Fred Howard Park to honor military veterans on the 4<sup>th</sup> of July (Independence Day) holiday and requested staff to bring back a policy for future observances, estimating the financial impact on budgeted revenues.

Staff has considered the three patriotic holidays recognized as federal holidays and typically associated with the service of our country's veterans; July 4<sup>th</sup>/Independence Day, Memorial Day and Veterans Day. Independence Day is celebrated annually on July 4<sup>th</sup> and commemorates the adoption of the Declaration of Independence on July 4, 1776. Memorial Day is celebrated every year on the last Monday of May to remember the men and women who died while serving in the country's armed forces. Veterans Day is observed annually on November 11<sup>th</sup> and honors all members who have served in the United States armed forces. Typically, if Veterans Day falls on a weekend, the national holiday observance is either the preceding Friday (if November 11 falls on a Saturday) or Monday (if November 11 falls on a Sunday).

A survey of several other urbanized and or neighboring Florida counties, including Broward, Hillsborough, Orange, Pasco, Sarasota and Lee, as well as the City of Clearwater, indicates no special designation or fee waiver associated with any particular veterans' observances (attachment No. 1). Several counties offer a discounted annual pass rate for active military and veterans, as well as free passes for disabled veterans.

**Fiscal Impact/Cost/Revenue Summary:**

Limited data is available as the parking fees at Ft. De Soto and Fred Howard parks have only been in existence since January 2012. Additionally, prior to October 2011, the City of Clearwater was responsible for beach parking fees at Sand Key Park. Other factors, such as the day of the week the holiday falls on, weather and season may also affect fee collections. Attachment No. 2 summarizes historical revenue collection on these holidays. Based on the analysis, the approximate loss of annual parking revenue for Veterans Day parking waiver is \$5,000 for Fiscal Year 2015.

**RESOLUTION 14-\_\_**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA, WAIVING CERTAIN FEES IN COUNTY PARKS ON THE ANNUAL FEDERAL VETERANS DAY HOLIDAY.

**WHEREAS**, Pinellas County Code Sec. 90-18 directs the Parks and Conservation Resources Department (“Department”) to charge fees for various uses of county-owned or managed lands (“Parks”), as such fees may be established by resolution of the Pinellas County Board of County Commissioners (“Board”); and

**WHEREAS**, the Board has established fees for the use of County Parks in the Board’s annual User Fee Resolution (“Fee Resolution”); and

**WHEREAS**, the Board wishes to waive certain Fees each year in observance of the annual Veterans Day Holiday;

**NOW, THEREFORE**, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY FLORIDA, AT A DULY ASSEMBLED MEETING HELD ON THIS \_\_\_\_ DAY OF \_\_\_\_\_, 2014, AS FOLLOWS:

**Section 1.**

The Board hereby waives the following specified fees effective each year on the date federally designated for the observance of the Veterans Day Holiday: the daily parking fees in the Boat Ramp Parking Fees section of the Fee Resolution and the Fort DeSoto Park, Sand Key Park and Fred Howard Park (beach) Parking Fee section of the Fee Resolution.

**Section 2.**


This Resolution shall take effect immediately upon its adoption.
