Co-Applicant Board Composition Requirements

- Board must be composed of individuals, a majority of whom are being served by the center and, this majority as a group, must represent the individuals being served by the center in terms of demographic factors such as race, ethnicity, and sex.
- Board must have at least 9 but no more than 25 members, as appropriate for the complexity of the organization,
- No more than two (2) MMU Advisory Council members may be Pinellas County Board of County Commission members,
- The remaining non-consumer members of the board shall be representative of the community in which the center's service are is located and shall be selected for their expertise in community affairs, local government, finance and banking, legal affairs, trade unions, and other commercial and industrial concerns, or social service agencies within the community;
- No more than one half (50% - for CHCs) of the non-consumer board members may derive more than 10% of their annual income from the health care industry.
- No employee or immediate family member of an employee of the public agency, or the co-applicant may serve as a member of the co-applicant board.

**Minutes of the Monthly Meeting of the
Mobile Medical Unit Advisory Council (MMUAC)
December 1, 2015 | 3:00 pm**

Present at Meeting: Laurie Lampert, Valerie Leonard*, Dianne Clark, and Rhonda Abbott. Staff and community members present: Dr. Chitra Ravindra, Drew Wagner, Dale Williams, Daisy Rodriguez, Katherine Simone, and Elisa DeGregorio. (*Consumer)

The regular meeting of the Mobile Medical Unit Advisory Committee (MMUAC) was called to order at 3:07

1. Chairman's Report

- i. **New Member Appointment:** Ms. Leonard informed the group that Margaret Matte who participated in the November meeting of the Council, could not join us today due to a medical issue. She has indicated that she is still interested and would try to attend next month.
- ii. **Approval of Previous Minutes:** A motion to approve the minutes dated November 3, 2015, was made by Rhonda Abbott, seconded by Valerie Leonard and **unanimously approved**.
- iii. **Credentialing & Privileging:** The Department of Health provided a copy of the Medical Committee Meeting Minutes from November 24, 2015, a copy of the Credentialing and Privileging Tracking List recommending Sharon Engelman, Dentist for credentialing & privileging by the Council and the Specialty Care Provider list with 56 additional names highlighted in yellow recommended for approval. A motion to approve the specialists for credentialing & privileging was made by Dianne Clark, seconded by Rhonda Abbott and **unanimously approved**.
- iv. **Unfinished Business:** In follow-up to last month's meeting, the following items were discussed:
 - a. **Patient/Consumer Recruitment for MMUAC:** In follow-up to the discussion last month, Daisy Rodriguez reported that she has worked with communications to develop a flyer that can be distributed at the various shelter, the van, and to any provider who serves homeless individuals. The flyer would bring awareness to the population and to the providers that there is this Council/Governing Board and that we are continually seeking patient/consumer representation on the board. Ms. Rodriguez passed a couple versions of the flyer around and asked for additional input.

Also in follow-up to last month, we discussed arranging for meeting space at the different shelter locations where the meeting can be held. Staff is continuing to work with the shelters to identify a location and will build the schedule for 2016 incorporating the additional/new spaces. We may move locations or offer them as satellite locations connected by a conference call line.

There is still significant concern about the transient nature of the population and their ability to consistently attend meetings as required by the bylaws. Ms. DeGregorio urged

the Council to focus on getting individuals to show up to one meeting at a time...as we continue to have a waiver in place for the patient majority. We can work with the individuals once we identify a few who might have an interest.

Rhonda Abbott asked if it is possible for each shelter/provider to have a “consumer” seat on the board and have the ability to fill the seat each meeting with an available patient/consumer representative. Ms. DeGregorio will look into the question further with the federal project officer.

- b. HEP/Lealman Van Locations:** Regarding HEP (Homeless Empowerment Program), Drew Wagner reported that he met with Zach White at HEP and with the County Risk Department who approved the location for parking the van at HEP. The space will actually accommodate the MMU van as well as the BayCare van when the AHCA grant becomes operational. There is also an inside space available when the van is not. For both inside and outside the location would be open to all homeless citizens. Mr. Wagner suggested starting service on January 1, 2016 by eliminating the 2nd Tuesday every other week at Pinellas Hope and replacing it with HEP. Rhonda Abbott made a motion to accept Mr. Wagner’s recommendation for including HEP in the van rotation schedule and starting service in January 2016. Dianne Clark seconded the motion and it was **unanimously approved**.

Ms. Rodriguez reported that both her and Lourdes Benedict took a tour of the Lealman area last week with Neil Brickfield in response to his request to add a location within Lealman for the van to provide primary medical care services. She suggested that while the need for medical care is great, she had a question about the concentration of homeless individuals within the area that would result in a productive service opportunity for the van. They also have not yet found a location suitable for the van to provide service that also would be as close to the most homeless individuals in the area. Mr. Wagner recommended that we put the location on hold until a location is found that can be scouted by the staff and the County Risk Department. At that time, the County can assess the need of the population and bring the full recommendation back to the board for review and consideration. All the Council members in attendance agreed to the recommendation, though no formal vote was taken.

I. Governance/Operations

- i. MMU Calendar:** The December calendars (included in the meeting packet) for the MMU and Safe Harbor was presented to the Council by Andrew Wagner.

Mr. Wagner informed the Council that the van had been out of service for a majority of the service days in November due to mechanical issues as well as the 3 holidays in November (Veterans Day, Thanksgiving, and the day after Thanksgiving).

In December, the health center would be closed on 25th and the 26th. It was also possible that they may close on the 24th if the Governor issued time off for state employees. He also added that the health center would be closed on January 1st and 2nd due to the New Year’s holiday weekend.

- ii. Site Visit Status of Conditions Update:** Elisa DeGregorio, Grants Manager, indicated that there had been no change on the on-going effort to lift the conditions on the grant that were identified as a result of the site visit in 2014. In November, Ms. DeGregorio reported that now four (4) of the

seven (7) original conditions have been lifted from the grant including the Sliding Scale Discount Fee, After Hours, Hospital Admitting and Continuum of Care, and Credentialing & Privileging. The Board Authority condition has been moved into a 60 day action and is due on 12/21/15. Ms. DeGregorio confirmed that we had all the necessary information to resubmit documentation for this condition. The remaining two conditions have been submitted for review by HRS within the deadlines established including Substance Abuse Services and OB/Pre-Natal.

- iii. **Policies and Procedures:** Ms. Daisy Rodriguez briefly reminded that council that staff presented four new policies in draft form for consideration by the Council in November and that this month we were seeking their final approval. These new policies (Selecting a Personal Clinician, After Hours/Clinical Advice, Appointment Access, Missed Appointments/No Shows) were included in the meeting packet for review. Ms. Rodriguez further explained that these new policies were being established in accordance with recommendations for the Patient Centered Medical Home Recognition that the health center is pursuing. A motion was made by Rhonda Abbott to accept the new policies and procedures, seconded by Dianne Clark. The Council **unanimously approved** the four new policies.
- iv. **Client Handbook:** Ms. Daisy Rodriguez updated the Council that the handbook is continuing to be finalized and that while the full scope of the handbook is a requirement of the PCMH recognition program, she acknowledged the need for a shorter version or even a “pocket card” style tip sheet for clients who will not carry such a long document. Once these are finalized, final documents will be presented to the board for their review and approval.

II. Fiscal

- i. **Notice of Awards:** Ms. DeGregorio reported that no new Notice of Awards from HRSA were received since the November 3, 2015 meeting. She noted that we are expecting an agreement for the State AHCA grant soon and that it would be presented to the council for acceptance at the next meeting.
- ii. **Oral Health Services Expansion Funding Opportunity & Grant Application:** Ms. DeGregorio informed the Council that a new funding opportunity was released by HRSA on November 17, 2015 for Oral Health Service Expansion. The application allows for up to \$350,000 per year for two years to increase access to oral health care services and improve oral health outcomes for Health Center Program patients. In a grant conference call review meeting earlier in the day, the staff and community partners brainstormed some funding opportunities for this grant. We will be looking at funding a full-time dental team (Dentist, Hygenist, and Dental Assistant) at the Bayside Health Clinic. We will also look into funding the dentures program for an additional two years. Another opportunity we will look at is around ER Diversion for oral health. The Department of Health recently applied for and received AHCA funding from the State to begin a dental ER Diversion program. Being that the funding from the state will end June 30th and this opportunity, if awarded would be available July 1, there would be a seamless transition of this program funding stream. Another aspect that has been called upon is the need for better navigation services – a resource guide/staff to help individuals understand the resources/eligibility of the various programs and where to get help. Ms. DeGregorio stated that we will be pulling the grant application together over the next month and that the first of a two-tiered deadline is January 19th. Ms. DeGregorio sought a motion from the Council to approve the submission of the grant application. Rhonda Abbott made a motion to approve the County’s grant application for the OHSE funding opportunity. The motion was seconded by Dianne Clark and **unanimously approved**.

III. Clinical

- i. **Trend Report for Patient Counts/Encounters:** A copy of the November trend report was provided to the Council members indicating that a total of 2,109 unduplicated patients were recorded from January 1st through November 30th for the program. The numbers for November were down slightly due to the van being out of service and only being able to provide inside services for a majority of the month. He also noted that the census at Safe Harbor is also still down due to the warmer weather still lingering in the area.

The target patient projection for 2015 is 2,390 unduplicated patients. With one month left in the calendar year, we will be close or just shy of meeting that projection. Ms. DeGregorio informed the Council that as long as we are within 5% of the patient target projection we should not experience any reductions in funding. She also noted that we are well above last year which for the same time period the health center served 1,643 patients.

- ii. **Patient Centered Medical Home:** Dr. Ravindra reported that we are continuing our work on the Patient Centered Medical Home initiative. We continue to make progress on the required elements/factors required to achieve Level I recognition. Ms. Rodriguez, Mr. Wagner and Rhonda O'Brien would be meeting next week to inventory our progress and potential points total towards the Level 1 recognition.

IV. Other Updates

- i. **Bayside Health Clinic:** Daisy Rodriguez reported that construction on the clinic remains on track with the slab poured and steel going in for the roof in the next couple weeks. Ms. DeGregorio shared some photos taken at the site with the Council. The contractor is still slated for completion by the March 30th deadline.
- ii. **New Business:**
 - a.) **Prescriptions from Hospital Discharge:** Laurie Lampert inquired about prescriptions given to a client upon discharge from the hospital especially when discharge occurs on a Friday afternoon. Dr. Ravindra informed Ms. Lampert that the pharmacy has orders to dispense a 3-day supply of medications to clients upon discharge and within 3 days the County would then be able to arrange for the follow-up with the doctor who will then fill the remaining prescription. If she has any pharmacy unwilling or is unaware of that directive to call Drew or the staff immediately. With the new pharmacy contract in place the staff are still working out the kinks with all the new pharmacies in the plan.

The meeting was adjourned at 4:16 pm.
