#### **CURRENTLY SCHEDULED APPLICATIONS**

### 1. VAR-21-18 Conditional Approval

Application of Andrew and Melissa Larsen, through Phil Larsen, Representative, for a variance to allow for the construction of a 780 square foot detached accessory dwelling unit where 750 square feet is the maximum size allowed in the R-3 zoning district for the property located at 1442 Blanton Ln, in Unincorporated Clearwater.

## 2. VAR-21-20 Conditional Approval

Application of William S. Stewart, for a variance to allow for the construction of an accessory structure having an 11-foot side setback from the eastern property line fronting Stiles Lane where 15 feet is required in a R-R zoning district for the property located at 1661 Laney Drive in Palm Harbor.

## 3. VAR-21-22 Conditional Approval

Application of Gaetano Critelli, through Terry Coyle, Representative, for the construction of a 9-unit townhome subdivision in a C-1 zone, for the property located on the south side of Park Boulevard approximately 110 feet west of Oakhurst Road in unincorporated Seminole.

Application of Northstar Cemetery Services of FL, LLC, through Stacy Adams, Representative, for a Type-2 Use to allow for the expansion of an existing cemetery in an R-A zone with the construction of a new 1,444 square foot memorial niche building, for the property located at 5750 49th Street North in Lealman.
