HR Update – Maria Ciro, Assistant Director of Human Resources

- Scorecard Met our 2022 service goal
- Current Scorecard Received 20 responses for January
 - Total Satisfaction 100%
 - Professional & Courteous 100%
 - Helpful 100%
 - Received requested information timely 100%
- Stepping Challenge The stepping challenge encourages employees to get moving. The challenge begins at the end of January.
- Biometric Screening This year the Biometric Screening end date is November 30th
 - There is a 30 day blackout period, so ending on November 30th will allow us to begin on January 1st in 2024.
- Biometric Screening Almost 500 employees did not complete their Biometric Screening in 2022
 - Question Do you survey these employees to ask why they chose not to complete the screening? Answer – We don't, but that is a good idea; perhaps we can in the future.
 - Question What happens with all that money; 500 employees at \$500 each is \$250,000?
 Answer The funds are used to cover medical claims.
- Annual Report The HR 2022 Annual Report is being created. C.A.R.E.S.
- Communication Survey We will be launching a survey in March to analyze how employees would like to receive important information from HR.
- Time to Fill The time-to-fill for January was 73.8 days.

- What happens at the Tax Collector's Office -
 - Collect Property Taxes

 - o Issue Titles, Registrations and Driver's Licenses
 - Sell Birth Certificates to Florida Born Citizens
 - Under an agreement with Vital Statistics
 - Sell Hunting and Fishing Licenses
 - Process Concealed Carry License Requests

- Do not issue; just process
- Fee Office The Tax Collector is referred to as a "Fee Office" as they earn enough in fees to be self-funded.
 - \circ $\,$ Any unused fees are returned to the state.
- Sterling Management System The Tax Collector's Office utilizes the Sterling Management System, which is a data driven system with 7 elements that come together to make it work
 - o Leadership
 - o Strategic Planning
 - Customer Focus External
 - Employee Focus
 - Knowledge Management
 - Innovation and Diversity/Inclusion
 - Metrics
- Charles Thomas
 - $_{\odot}$ Moved to Florida 33 years ago and opened a Vehicle Emissions Business
 - Emissions was voted out in 2000, and at that time he assisted the former Tax Collector, Diane Nelson, with her campaign, and then was hired as the Deputy Tax Collector.
 - Served as the Deputy Tax Collector for 16 years, and ran for Tax Collector after Diane Nelson retired
 - $\circ~$ Charles and wife Patti have been married 43 years
 - Have two children and two grandchildren
 - Sadly one passed much too young from Leukemia
- Question What are your thoughts about potential changes to short term rentals? Answer I am not sure how changing the use of personal or rental property will affect us, but we will collect taxes either way.
- Question Do you plan to continue with the appointment system that you are currently using? Answer – Yes, I plan to continue with appointments only. 80% of customers say that they are happy with the appointments
- Question Do you have any plans to open up additional, smaller, locations throughout the county? Answer – No, we have 4 locations throughout the county. We had two smaller locations that were closed due to some staffing difficulties; if someone called out and someone else was off, the wait times were quite long.
