

# Pinellas Partners in Recycling Meeting Notes for July 12, 2023

Virtual Meeting

## **Overview and Attendance**

# **Updates**

## **State Updates**

### Florida Department of Environmental Protection

• Chris Perry shared that the <a href="2022 Solid Waste Management Report">2022 Solid Waste Management Report</a> for state of Florida has been completed. Including renewable recycling credits, the statewide recycling rate is 48%. The traditional statewide recycling rate is 41%. Palm Beach County achieved 80% recycling rate,



earning them top recycler of the year. The top 10 had an average recycling rate of 67%. Pinellas County's recycling rate for 2022 is 67% (6<sup>th</sup> in rank). Total waste generated increased by 792,000 tons or about 1.6% over 2021. More waste was landfilled than recycled in 2022.

# **Regional Updates**

#### **Pinellas County**

- Emily LeMay shared that the County is working with a consultant (NewGen Strategies & Solutions, LLC) to locate and survey commercial food waste generators in the County. This will help gauge whether there is interest in a potential commercial food waste separation/collection program as recommended by the <u>Solid Waste Master Plan</u>. The County will also be working with NewGen to conduct a countywide recyclable materials composition study in the fall and will share details with municipalities to participate. This study will generate a countywide contamination rate and serve as an update to the <u>2020 study</u>.
- Emily LeMay shared that a Communication Plan for the Fiscal Year (FY) 2024 Disposal Fee increase of 6.8% is underway. In 2022, the Board of County Commissioners approved Resolution 22-48, which increases the rate for disposal of municipal solid waste, commercial waste, and yard waste to \$51.00 per ton effective October 1, 2023. Additional fee increases will be considered as part of the FY24 budget.
- Stephanie Watson shared that the County has been advertising and holding public input
  meetings for proposed changes to the Solid Waste ordinance. The information gathered at these
  meetings will be presented to the Board of County Commissioners in August alongside the
  information that was gathered by surveying and meeting with the County's private haulers and
  municipal partners. The public input meetings have garnered a lot of media attention:
  - <u>Tampa Bay Times Pinellas seeks input for mandatory recycling, facing solid waste</u> strain

- Ashley Wyland shared that the <u>Household Hazardous Waste (HHW) Center's</u> operational hours have changed effective June 1, 2023. The hours are now 7 a.m. to 5 p.m., Tuesday through Friday and the 1<sup>st</sup> and 3<sup>rd</sup> Saturday of the month. On the 2<sup>nd</sup> and 4<sup>th</sup> Saturday of the month, Household Chemical Collection (HCC) Events are held at 29582 U.S. 19 N., Clearwater. This is an increase the amount of HCC events. An <u>online calendar</u> (for the HHW Center and HCC events) is available.



- Ashley Wyland previewed website changes. The website traffic to the Where Does It Go? Search Tool usage has been in decline since the County moved to a new WordPress website in October 2022. Ashley showed the many places that the Search Tool is featured on the website with the hopes that it increases use. Ashley also showed that the Solid Waste Disposal Complex Personal Protective Equipment requirements are now featured on the website in multiple places to make the information more accessible and intuitive to locate.
- Ashley Wyland will be reaching out to municipalities and their PIOs regarding recommended changes to municipal websites to align with recent Department of Solid Waste program changes. Ashley reviewed municipal websites and found outdated information, so this will help bring municipal website information in line with current County information.
- Jasmine Scott shared that the reimbursement requests for the Fiscal Year 2023 Municipal
  Recycling Reimbursement Grant (MRG) are due September 15. Stephanie Watson added that
  there will potentially be changes to the eligibility criteria. Stephanie is meeting with the
  Technical Management Committee (TMC) on July 26 to discuss proposed changes. The goal is to
  revise the MRG to help standardize public education for mixed recycling collection programs in
  Pinellas County. 24 municipal recycling programs have different rules and is often an area of
  confusion for residents.

#### **City of Tampa**

- Edgar Castro Tello shared that they recorded some videos in partnership with Zoo Tampa for Plastic Free July (not published yet).
- The City of Tampa is participating in Plastic Free July EcoChallenge.

## **Pinellas County Municipal Updates**

#### **City of Largo**

- Julianne Perez shared that the City is working on expanding their contract with Keep Pinellas
  Beautiful (KPB). The contract expansion adds additional services to their existing contract, and it
  will now cover cleanups (agree to minimum number that the City will be the coordinator for),
  education (will provide the City sustainability outreach staff), and videos (will create Spanish and
  English conversation about recycling). Julianne noted that other larger municipalities participate
  in this type of contract with KPB and asks for feedback on what to focus on or what may work
  well. Email Julianne at jperez@largo.com.
- The City has appointed Shelby Beauchemin as Interim Public Works Director and is working hiring a new City Manager. Currently also hiring for a Solid Waste Manager.
- Holding a work session on Tuesday, August 8 at 4:00 pm for a Sustainability and Resilience
  Action Plan update. Session will be recorded. City's Sustainability Coordinator will present on
  energy roadmap.

#### **Contract Work Group**

- Jasmine Scott previewed the new contract database in SharePoint that is managed by the
  Department of Solid Waste. It was an action item in the Work Group Charter for the team to
  maintain. It's available to everyone, but you'll need to request it by emailing
  recycle@pinellas.gov. The next Contract Work Group meeting Monday, 9/18/23 from 10:00am
  to 11:00am.
- Stephanie Watson added that the County's Department of Solid Waste is here there to support municipalities at board meetings to advocate for recycling programs.

#### **Contamination Work Group**

 Ashley Wyland shared that the survey for interception interviews has been completed. The next Contamination Work Group meeting is July 27 at 11:15am. Ads are in progress with the County's Communications/designer for the rechargeable battery ad campaign.

## **Low Waste Event Guide Work Group**

Emily LeMay shared that the next meeting is August 3at 10 a.m. and that the group is currently
meeting monthly. Moving forward, meetings will be themed; for example, the next meeting will
bring in speakers to share about their own Low Waste or Zero Waste Event Guide drafting
process. The Charter is on the <a href="PPR website">PPR website</a>. The Work Group is building out a Table of Contents
for the Low Waste Event Guide and will target sections to work on as a group.
