Election of Officers

Presentations

Devon Francke gave a presentation on <u>Keep Pinellas Beautiful</u>'s (KPB) work related to microplastics and community engagement to address microplastics in the community. - Marine debris and plastic pollution originates inland and washes into the ocean at an estimated rate of 8 million metric tons every year or 1 garbage truck of garbage per minute.
- The negative effects of ocean pollution include habitat destruction, navigation/safety hazards and negative tourism impacts. Plastic in the environment breaks down into smaller and smaller pieces of plastic or microplastics and can be found everywhere; in freshwater, ocean water, the air, bottled water, tap water and the food we eat.
- Microplastics are more dangerous than other pollution because they contain and attract chemical contaminants, can lead to marine life population decrease and have negative ecological and biological health effects. Humans are consuming one credit card worth of plastic every year, but the effects of microplastics on humans are still unclear.
- KPB has a microplastics program; volunteers are citizen scientists who collect countywide samples and study contents for microplastics. KPB uses this data in their education program that includes handouts, videos, outreach events, presentations, clean-ups and their new curriculum "The Story of Plastics" available to the public for free at https://tinyurl.com/kpbcurriculum. KPB's education program encourages the community to prevent pollution and help educate others.

Diane Daniel, a part- and long-time resident of Indian Rocks Beach started Vacation Donations as a passion project organization that serves as an information resource to help vacation rentals and tourists reduce their waste. - Pinellas County has about 10,000 vacation rentals. The problem Diane noticed is that tourists in vacation rentals purchase food, beach toys and other household products that end up going to waste once they return home.
- Vacation Donations is a non-profit organization that connects tourists and vacation rental property managers to reuse and recycling outlets for commonly used vacation items online at https://www.vacationdonations.org/.



• Some programs that Vacation Donations facilitates are take a toy and leave a toy bins, a food pantry bin for non-perishable unopened food at Indian Rocks Beach City Hall and refrigerator magnets for vacation rentals.

The scope for the Countywide Recyclable Materials Composition Study is finalized and Solid
Waste expects the sampling plan this week. Solid Waste will reach out to municipalities to
formally ask for participation and will give estimated cost and number of total samples needed
for countywide statistical significance. Municipalities can request additional samples to get more
accurate data. The study gives the county countywide contamination rate and top
contaminants.

- The fiscal year 2024 Municipal Recycling Grant program reimbursement request packet was sent to all municipalities in December. Reimbursement requests are due Sep. 15, 2024. Municipalities have the option to use their allocation to pay for participation in the recyclables composition study. If you wish to do so, wait for additional instructions.
- The Residential Recycling Awareness survey will be kicking off in the next 2 months. The last report was in 2020. The purpose is to gauge residents' understanding of and participation in recycling programs, learn where residents get their information and understand their recycling habits.
