SUBJECT: Draft Ballot and Charter Language - Charter Amendment Providing for

Term Limits for County Commissioners

Pursuant to the CRC's discussion at its March 21, 2024 meeting, please find following for the CRC's review and discussion various drafts of ballot and charter language for a charter amendment providing for term limits for county commissioners.

As discussed at that meeting, the CRC requested the preparation of a series of options for commissioner term limits, generally centering on either:

- 8-year term limits with a 2 year "cooling off period" before an individual could run for commission again; or
- 12-year term limits with a 4 year "cooling off period".

Discussion was also had concerning the application of the term limits to sitting county commissioners. The CRC discussed a number of options, including setting some sort of separate, potentially shorter term limit for sitting county commissioners, or having a certain number of past years of service count toward the generally established term limits, by making terms beginning at some point in the past count toward the term limits.

After initial drafting attempts, in light of the 75-word limitation on ballot summaries, and in the interest of avoiding voter confusion, the drafts included herein center upon varying the application of term limits to sitting county commissioners by making the term limits retroactive to various November general elections.

Attached as Exhibit "A" is a composite draft, laying out each of the options consistent with the structure described above. Attached as Exhibits "B" and "C" are clean examples of the language with 8-year/2-year limitations and 12-year/4-year limitations, to review as they might appear on the ballot. Exhibits "B" and "C" list dates from which the term limits would count as November 3, 2026 and November 5, 2024, respectively, but these are ultimately just placeholder dates to be revised at the CRC's direction.

Accordingly, this spreadsheet will be further reviewed, and any errata will be noted by subsequent communication. In addition to a PDF of the spreadsheet, CRC Commissioners will be provided with a copy of the original Excel spreadsheet in case any have an interest in further analysis.

A. Ballot Proposal: The ballot title and summary for this question are as follows:

COUNTY CHARTER AMENDMENT PROVIDING FOR COUNTY COMMISSIONER TERM LIMITS

Shall the Pinellas County Charter be amended to provide for County Commissioner term limits by prohibiting County Commissioners who have held the office for the preceding [8 years] OR [12 years] from appearing on a ballot for reelection and requiring a minimum of [2 years] OR [4 years] off the County Commission before serving again, with terms of office beginning on or after [November 6, 2018] OR [November 3, 2020] OR [November 8, 2022] OR [November 5, 2024] OR [November 3, 2026] counting toward the term limits. B. Text Revisions: Upon approval of this question at referendum, the following portions of the Pinellas County Charter are amended to read as follows:

Sec. 3.01. Board of county commissioners.

- The legislative body of county government shall be the Board of County Commissioners. The Board of County Commissioners shall consist of seven commissioners, with four of the seven commissioners residing one in each of four county commission districts, the districts together covering the entire county and as nearly equal in population as practicable, and each commissioner being nominated and elected only by the qualified electors who reside in the same county commission district as the commissioner, and with three of the seven commissioners being nominated and elected at large. Each of the three at-large commissioners shall reside one in each of three districts, the three districts together covering the entire county and as nearly equal in population as practicable.
