## WELCOME AND INTRODUCTION OF PSCC MEMBERS

Chair Eggers called the meeting to order at 2:00 PM and requested that those in attendance introduce themselves.

## **APPROVAL OF MINUTES**

Chief Judge Crane made a motion to approve the meeting minutes of February 5, 2024. The motion was seconded by Mr. Bartlett and carried unanimously.

## **PUBLIC COMMENTS**

There was no response to Chair Eggers' call for public comment.

## **REPORTS**

# **Indicators Report**

Referring to a document titled *Indicators Report, May 2024*, Ms. Gonzalez noted that the average daily population for pretrial misdemeanors increased slightly in January, February, and March when compared to the previous year; and that this will be monitored due to the potential for the statute regarding public camping to take effect. Thereupon, a discussion ensued regarding the statute.

# Department of Juvenile Justice (DJJ) - Juvenile Detention Center (JDC) Data Report

Ms. Gonzalez indicated that no one is present for this item due to issues with the system utilized for this report.

## COMPLEX CASE REINTEGRATION PROJECT

Mr. Jalazo reviewed project statistics, noting that there are currently 21 individuals enrolled and 12 successful completions; that there has been growth in enrollment; and that there is intent to continue the program for another year if approval is received from the state.

### **OLD BUSINESS**

## Vacant Seat Nominees

Referencing a discussion at the Council's last meeting regarding the process for filling vacancies and the nomination of Operation PAR CEO, Jim Miller, for a current vacancy, Mr. Burns provided brief information related to the establishment of the PSCC and its Planning Council and discussed the vacant position, which spans both Councils, for a four-year appointment of a Director of a Local Substance Abuse Treatment Program or a designee; whereupon, he indicated that he has received no further nominations from the members; and that Mr. Miller is willing to serve in this capacity.

Mr. Jalazo made a motion to appoint Mr. Miller. The motion was seconded by Mr. Shea and carried unanimously.

Mr. Burns also discussed two current Planning Council vacancies and noted that, based on statutory language, the recommendations for filling the vacancies will be made by Florida Department of Children and Families Regional Substance Abuse and Mental Health Director Melissa Leslie; and that Ms. Leslie will work with staff to identify the recommended appointees, which will then be presented to the Council.

# **PSCC Website & Member Packets**

Later in the meeting, Ms. Gonzalez referenced materials provided to the members and discussed a proposal for a PSCC page on the County's website, noting that it would include the Council's purpose, mission, vision, contact information and a list of the members; whereupon, she related that meeting agendas and minutes, as well as any other information that the members feel is relevant, could also be added.

Mr. Jalazo made a motion to accept the website proposal, with the provision that the Council conduct a final review before it goes live. The motion was seconded by Mr. Dudley and carried unanimously.

#### **NEW BUSINESS**

Chair Eggers indicated that he would like to explore whether there is interest in bringing forward ideas to discuss at future PSCC meetings; whereupon, he invited Mr. Burns to address the topic.

Mr. Burns related that member survey feedback showed an interest in learning about community programs and initiatives; whereupon, Mr. Jalazo suggested a presentation regarding Infectious Disease Elimination Act (IDEA) Exchange Pinellas.

In response to a query by Mr. Dudley regarding the opioid settlement and how the money is being spent in Pinellas County, Mr. Burns indicated that a briefing related to the Opioid Task Force can be presented at the Council's next meeting; and that regular briefings can also be provided.

## **ROUNDTABLE/UPDATES**

Mr. Dudley provided information related to the efforts of the Office of Community Corrections and extended an invitation to the members to attend an upcoming innovation session; whereupon, Chair Eggers requested that the meeting information be sent to Ms. Gonzalez for forwarding to the members.

## **ADJOURNMENT**

The meeting was adjourned at 2:34 PM.
