### Sarah Soteroff, Too Good To Go


Too Good To Go (TGTG) is the social impact company behind the world's largest marketplace for selling surplus food. TGTG connects businesses directly to consumers via their marketplace to sell food at a discount so that it does not go to waste. This helps businesses recoup what would otherwise be lost revenue, helps consumers save money on food items they'd otherwise pay full price for and helps everyone to positively contribute to the fight against food waste and rising temperatures.

Sarah will give an overview of the food waste volume and impact globally and with specific reference to the US. TGTG's solution works to lessen food waste at the retail level with specific benefits for businesses and the consumer appeal for users. Sarah will showcase TGTG's growth since launching in 2016 and later coming to the US in 2020. TGTG now operates in 19 countries, and given that this is a global issue without borders, the impact of global collective action is important.

#### Presentation Notes:

0

• 40% of all food is wasted globally (see chart below of where it's coming from) and accounts for 10% of the worlds greenhouse gas emissions.



 About 50% of that food is wasted at the household level. \$2K worth of food wasted per year per person.



- TGTG is a for-profit company, the businesses make money, has help customers save \$168M worldwide.
- Founded in Denmark in 2016.
  - Problem: Hard for businesses to donate food because of liability (except FL has Good Samaritan Law)
- Came to Miami in 2021 and expanded to more areas of FL in Nov. 2023.
  - Since launching in the US, the app is available in 30 states.
- TGTG sells a surprise bag: Food waste is unpredictable a business isn't going to know
  exactly what they have. Food businesses always create extra food b/c they don't want to
  turn anyone away. Target: too small for donations, but too big that feels bad to throw
  away.
- Benefits to businesses: additional revenue, additional marketing and exposure to consumers, customers also may buy more than the TGTG bag when they pick up the bag.
- 23% of edible food that goes to waste is because of the best buy date.

# **Pinellas County Municipal Updates**

### City of St. Petersburg

- Vicki Fordyce
  - Presented at two schools for the Great American Teach-In & sent a truck to an elementary school. Presented on why waste reduction and recycling are important.
  - Have been seeing a lot of contamination in recycling bins due to storms residents using recycling bins for garbage.
  - Still dealing with storm debris. Contract collected 867K cubic yards of vegetative debris that is being ground into reusable mulch. Collected 300K cubic yards of c & d.
  - Monthly compost program delivered 20 bins over the past couple of months.
  - Updated <u>Good Neighbor Guide</u> for urban agriculture. Partnered with local farms on education and awareness for composing, farming and urban agriculture.

#### **City of Clearwater**

- Jonathan Campbell
  - o Working on removing storm debris, getting back to a sense of normalcy.
  - Participated in the Great American Teach-In & brought a truck for touch-a-truck event.
  - Going to high school career fair to promote careers in the solid waste and recycling industry.

#### **City of Dunedin**

- Savannah Bunch
  - 100K cubic yards of storm debris collected.
  - Re-opened recycling drop-off centers last week still experiencing some illegal dumping.
  - o Applied for a USDA composting grant haven't heard back yet.

#### **City of Temple Terrace**

• Joe Munoz: the city has completed vegetation cleanup from storms. Contractors are turning that debris into mulch.
