#### OLD BUSINESS:

#### Sports Ability Alliance Beach Accessibility:

- Terminology correction: Use "Beach Access Mat" instead of "MobiMat".
- Efforts to expand the project statewide.

- Jody will get an update on Statewide initiatives at the Family Cafe, when she meets with Sports Ability.
- Bright Futures scholarship applicant, Dillon Cornelius, has been surveying the beaches and collecting data. Jody is following up to ensure that the young man received his certificate of appreciation for his work.
- Updates on beach access mats:
  - Madeira Beach installed a second mat at Tom and Kitty Stuart Park but lacks accessible parking.
  - $\circ$   $\;$  Issues with mat replacement post-dune restoration; Indian Shores mat not reinstalled.
  - $\circ$   $\;$  Need for tracking municipal mat installations for accurate responses.
  - Fort De Soto and Honeymoon Island each have two mats installed.

## Presentation to the Board of County Commissioners:

- Creation of an infographic highlighting council achievements, with additional input requested.
- Positive feedback on the infographic's simplicity and informativeness.
- Plan to present the infographic to the Board of County Commissioners.

## Parks Accessibility:

- Discussion on improving Ridgecrest and other parks' accessibility.
- Emphasis on fully accessible new playgrounds, with features like ride-along swings.
- Ensuring playground renovations meet ADA standards and include necessary accessibility features.
