HABITAT AND TREE MANAGEMENT PERMIT APPLICATION

WHEN IS THIS FORM REQUIRED?

This form must be uploaded in the Accela Citizen Access portal when applying for any work that may impact vegetation, including but not limited to trees and tree roots, native vegetation, wetlands and wetland buffers, preserve areas, or conservation easements as described in the Pinellas County Land Development Code Chapter 166, Article II.

Once the application is received, staff will perform a site inspection to assess existing vegetation on the subject site. Please ensure that the property is accessible by providing any instructions or gate codes required, securing pets, and ensuring any trees or vegetation proposed for removal are clearly marked. If staff are unable to complete a successful inspection, you may experience delays and be charged a reinspection fee. You do not need to be present during the inspection. Review comments and inspection results will be communicated through Accela. If you do not provide an email address on the last page, you will not receive these system notifications.
