



Self-Reporting Help Guide: Dental Checkups and Skin Screenings

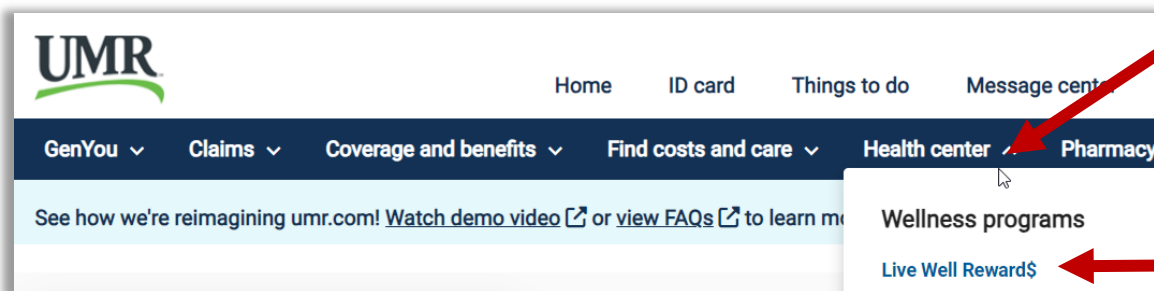
- In 2026, dental checkups and skin screenings *must* be self-reported to earn an incentive.
- **Dental Checkups:** Earn \$25 or 6,250 rewards points for a regular dental cleaning, exam, or X-rays, up to twice per calendar year, for a total of \$50 or 12,500 reward points.
 - Dental visits need to be reported as follows:
 - Checkup 1: Visit from January 1 – June 30, report by June 30, 2026 (you will *not* be able to enter checkup 1 after June 30).
 - Checkup 2: Visit from July 1 – December 31, report by December 31, 2026.
- **Skin Screenings:** Earn \$50 or 12,500 reward points for a preventive skin cancer screening. Visits for other reasons, including biopsies and other procedures, do not qualify.

NOTE:

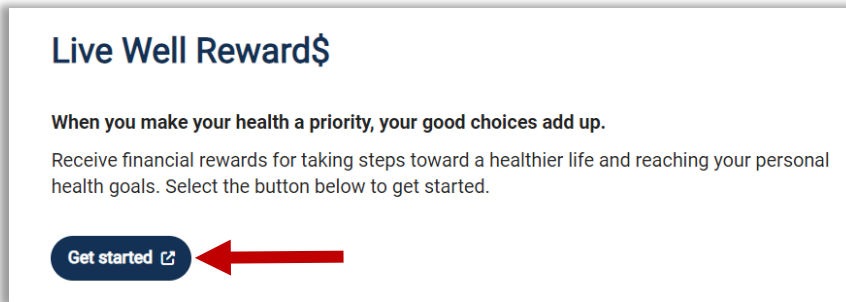
- Proof of screening is not required when self-reporting, but all self-reported activities are subject to random audit, per the [Wellness Program Incentive Rules and Guidelines](#).
- See [Opt Out Instructions](#) for those who opt out of the County's medical plan.
- See [Confirmation Instructions](#) to confirm that you reported a screening successfully.

Medical Plan Participant: Report a Dental Checkup and Skin Screening (for employees and spouses on the medical plan)

1. Log into www.UMR.com. See [UMR Login](#) for step-by-step instructions.
2. From the *Health Center* drop-down menu, select **Live Well Reward\$**.



3. Click the **Get Started** button under Live Well Reward\$.



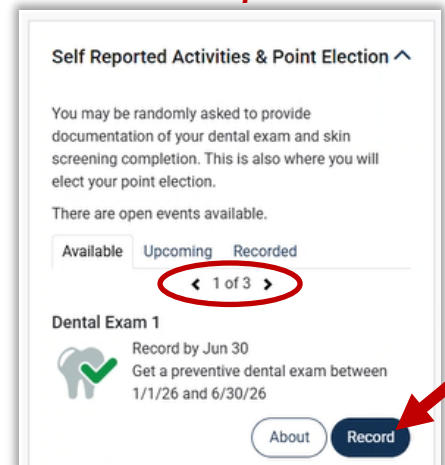
4. In the Live Well Reward\$ Wellness Platform, go to the column on the right, and scroll to the **Self-Reported Activities and Point Election** section.

Use the arrows (indicated with the red circle at right) to move left or right and locate **Dental Exam** (Example 1) or **Skin Cancer Screening** (Example 2).

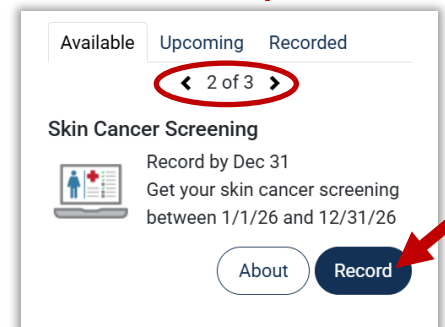
Click **Record**.

NOTE: For dental, you will only see Dental Exam 1 or 2, not both, depending on the current qualifying period. You cannot enter Exam 1 after June 30.

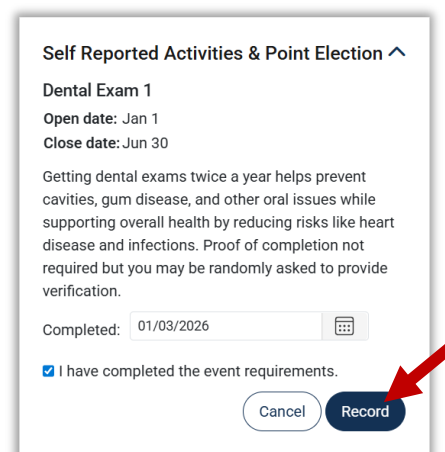
Example 1: Dental



Example 2: Skin

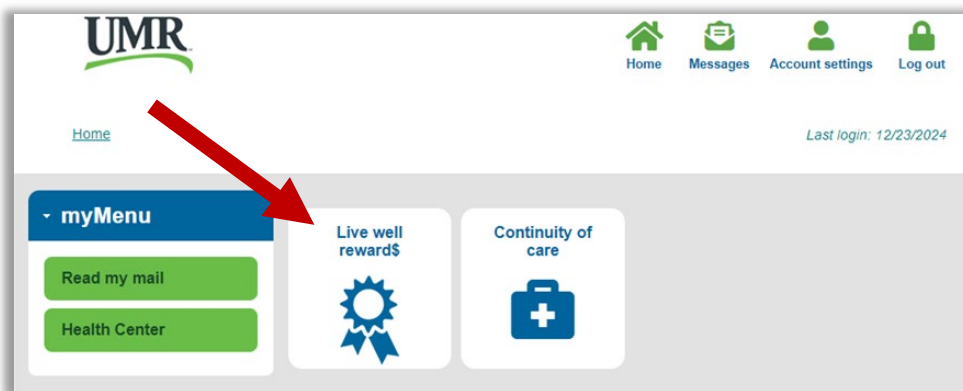


5. Complete the following items:
- Click the calendar and select the date of your dental exam or skin screening.
 - Click the checkbox to certify you have completed the event requirements.
 - Click **Record**.
 - NOTE: If you mistakenly enter the date for a different activity, click *Cancel* and then use the arrows to scroll to the desired option.



Opt Out: Self-Report Dental Checkup or Skin Screening (for those not on the medical plan)

1. Log into UMR's [Opt Out Wellness](#) site. If this is your first time logging in, you need to create a One Healthcare ID as prompted. Once you've created and verified your account, the first time you log in, you will be asked for a Member ID (enter your Social Security number) and a Group ID (enter: 76417193).
2. Click the **Live Well Reward\$** tile.



3. In the wellness portal, go to the middle column, and scroll down to the **Screenings and Point Election** section.

Screenings and Point Election

You may be randomly asked to provide documentation of completed screenings.

There are open events available.

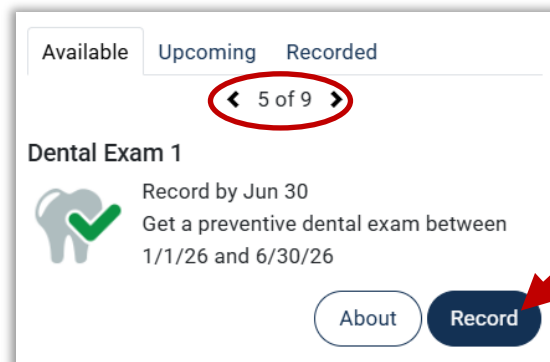

4. Locate the **Dental Exam** (or **Skin Screening**) option and click **Record**.

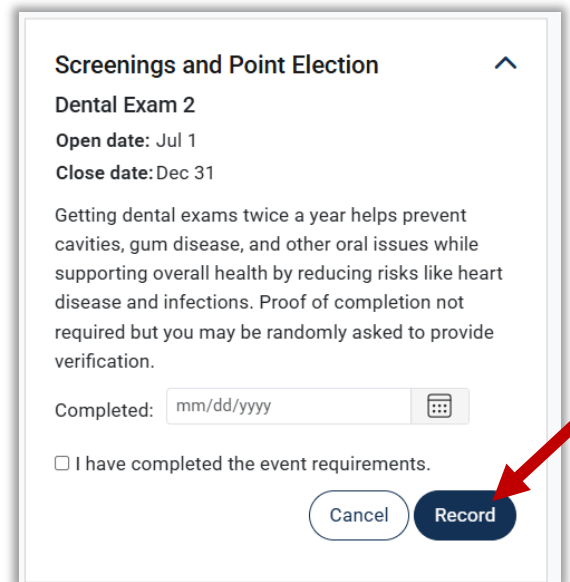
Use the arrows (indicated with the red circle at right) to move left or right to locate the desired activity.

NOTE: For dental, you will only see Dental Exam 1 or 2, not both, depending on the current qualifying period. You cannot enter Exam 1 after June 30.

5. Click the calendar and select your dental exam (or skin screening) date, click the checkbox to certify you have completed the event requirements, then click **Record**.



Screenings and Point Election

Getting dental exams twice a year helps prevent cavities, gum disease, and other oral issues while supporting overall health by reducing risks like heart disease and infections. Proof of completion not required but you may be randomly asked to provide verification.

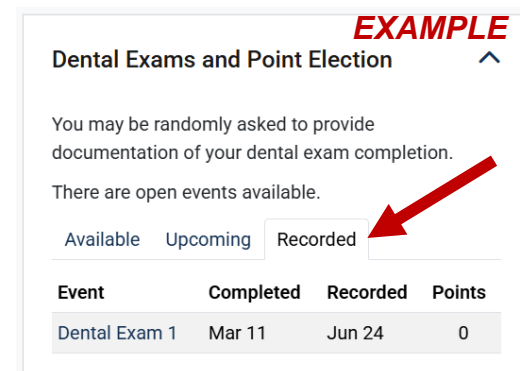

1. In the wellness portal, see the section for **Self-Reported Activities (Screenings) and Point Election**.
2. Click the **Recorded** tab and you will see **Dental Exam (or Skin Screening)** listed with the completed visit date and the date you recorded it on the website.
