An Ordinance amending the Future Land Use Map of Pinellas County, Florida, by changing the Land Use designation of approximately 4.82 acres located at 28870 US Highway 19 North in unincorporated Clearwater; located in Section 19, Township 28 South, Range 16; from R/O/R, Residential/Office/Retail (4.16 acres) and P, Preservation (0.66 acre) to CG, Commercial General (4.12 acres) and P, Preservation (0.70 acre); and providing an effective date; upon application of James Hamilton, DXD Capital, Applicant, through Amy McPherson of Stearns, Weaver, Miller, Weissler, Alhadeff & Sitterson, P.A. (Legislative)

2. DVA-26-02 (James Hamilton, DXD Capital) **Recommended Approval (Vote: 6-0)**

A Resolution for a Development Agreement on approximately 4.82 acres located at 28870 US Highway 19 North in unincorporated Clearwater; located in Section 19, Township 28 South, Range 16; with the Development Agreement limiting the buildable area of the property, limiting the maximum Impervious Surface Ratio to 0.70, and requiring a conservation easement on the non-buildable areas of the property; and providing an effective date; upon application of DXD Capital, Applicant, through Amy McPherson of Stearns, Weaver, Miller, Weissler, Alhadeff & Sitterson, P.A. (Quasi-Judicial)
